Introduction :

Purpose of the Fracture Clinic :

MGP fracture clinic is designed to provide specialized care and treatment for individuals who have sustained fractures. Our clinic offers prompt access to healthcare professionals who specialize in fracture management and can provide personalized treatment plans to ensure the best possible outcomes for our patients.

Clinic Services and Expertise :

Our fracture clinic provides comprehensive services, including but not limited to Evaluation and diagnosis of fractures.

Treatment planning and management of fractures, including:

- Casting, splinting, and bracing services.**

Appointment Process :

d. Informed Decision-making: Our healthcare providers will explain the benefits, risks, and expected outcomes of each treatment option, empowering you to make informed decisions regarding your care.

Follow-up care and Mentoring :

Following initial treatment, you may require periodic follow-up appointments to monitor your progress and ensure appropriate healing. Our clinic will schedule these appointments as needed and provide you with any necessary instructions or guidance to support your recovery.

As a private fracture clinic, our services are **not fully** covered by **Medicare**.

Our fees will be discussed with you during the appointment scheduling process, and payment will be expected at the time of service. We accept various **payment methods** and can provide you with a detailed **invoice** for **reimbursement**, if applicable.
